This is my last newsletter for 2020, and so I wanted to take this chance to wish you and your families a safe and very Merry Christmas. 2020 was the year we didn't expect, one many of us will be glad to have behind us, but it is also a year we saw the true strength, generosity and resilience of our community and our country.

Bushfires, floods, storms and COVID-19 have challenged our resolve, however we have emerged from 2020 in a good position and there are so many reasons to have hope.

Australia has performed better on the health and economic front than almost any other country in the world.

Over the last five months, 650,000 jobs have been created. 80% of the 1.3 million Australians who either lost their jobs or saw their working hours reduced to zero are now back at work. In October, there were 2 million fewer workers on

JobKeeper and around 450,000 fewer businesses on JobKeeper, compared to September.

It was wonderful to finish the year with the news that the OECD has upgraded its outlook for the Australian economy by 0.3 percentage points following the release of the Federal Budget.

All of this is great news for Australia and a great end to a challenging year.

In addition, the border openings have enabled so many of us to be reunited with family and friends for Christmas.

Setting the Policy Agenda in Immigration and Indigenous Affairs

In the last sitting fortnight, the two committees I chair have tabled their final reports for the Inquiries referred to them by the respective Ministers.

These reports are for:

- The **Inquiry into the Working Holiday Maker Program**, which has already had significant impact on the decisions made by Government to address the agricultural labour shortages our farmers are facing this harvest season; and,
- The **Inquiry into food pricing and food security in remote Indigenous communities**.

I have included detail about the two reports and their recommendations below, and media coverage of the reports below.

Recommendations dealing with agricultural and tourism labour shortages arising from international border closures

As Chair of the Joint Standing Committee on Migration, I tabled the Final Report for the Inquiry into the Working Holiday Maker (WHM) Program. This program is better known as the backpacker visa. The program contributes \$3.1 billion annually to Australia's economy and creates jobs all over Australia, particularly in regional areas.

WHMs also play a critical role in filling skills shortages across Australia, particularly in our horticulture, agriculture and tourism sectors.

The interim report dealt with the substantial agricultural and horticultural labour shortages due to the COVID-19 pandemic, however, this report largely focuses on longer-term changes to the visa program.

Industry groups, including [BYTAP](#) and [ATIC](#), have already expressed their support for the recommendations proposed by the Committee. As Simon Westaway of the Australian Tourism Industry Council said, *"This Report delivers tangible outcomes and if adopted by Government can help address future seasonal work vacancies for many tourism businesses across our regions."*

Addressing high food prices in remote Indigenous communities

As the Chair of the Standing Committee on Indigenous Affairs I tabled its report on food pricing and food security in remote Indigenous communities.

The report finds that food costs are very high in many remote communities, reinforcing long-held concerns regarding food security for Aboriginal and Torres Strait Islander Australians who are living remotely, however we did not find evidence of systemic price-gouging taking place in remote community stores.

Food security issues for remote Aboriginal and Torres Strait Islander communities are not new. The supply of quality and affordable food is often unstable due to poor infrastructure, seasonal changes, the high costs of living and operating stores remotely.

The report makes 16 recommendations to Government and can be accessed and downloaded from the inquiry website.

Industrial Relations Reform: Supporting Jobs and Our Economic Recovery

The Morrison Government's vital reforms to the industrial relations system are driven by one simple goal – breaking down the barriers to job growth so that we can get Australians back to work.

The reforms were developed after extensive consultation with employer and employee groups who sat down with the Government for more than 150 hours to find innovative solutions that will support struggling businesses, as well as protect and enhance the rights of workers.

The Fair Work Amendment (Supporting Australia's Jobs and Economic Recovery) Bill 2020 is the end product of that process, representing the most substantial reforms to Australia's industrial system since the Fair Work Act was introduced in 2009.

The Bill contains a range of practical measures targeting five key areas of the IR system:

- **Award simplification** – Cutting red tape, improving flexibility and job opportunities in 12 Awards covering the retail and hospitality sectors, which were hit hard by the pandemic and saw heavy job losses;
- **Greenfields agreements** - Boosting investment in job-creating mega-projects by making them more attractive to global investors through new maximum eight-year life-of-construction agreements, complete with appropriate safeguards and guaranteed wage increases;
- **Casual employment** - Ending the confusion and uncertainty surrounding the legal status of casuals, while providing a clearer pathway for those working regular shifts to convert to permanent roles after 12 months if they wish to do so;
- **Enterprise Bargaining** - Reversing the decline in agreement making by simplifying the BOOT test and setting a 21-day approval deadline to help drive productivity gains and real wage growth;
- **Compliance and enforcement** - Reducing the risk of wage underpayments by helping employers comply with their obligations, providing improved mechanisms to rectify underpayments where they do occur, and protecting employee entitlements by introducing a new criminal penalty with a four-year jail term for the very small number of employers who deliberately exploit their workers.

Helping Travel Agents to Process Customer Refunds

Recently I shared with you a speech I made to the Parliament about the unique challenges travel agents have faced during COVID-19, operating on little to no profit for more than six months, yet working hard to ensure Australians get their travel refunds. I suggested that the unique characteristics of the industry warranted industry-specific support.

The Morrison Government has just announced it will provide a one-off payment to assist travel agents. This announcement has been welcomed by the Tourism industry and I know will make a significant difference for many travel agents in the Berowra electorate.

Further Changes to Support Family Visa Applicants

Throughout 2020, people in our community have written to me regarding partner visas and the uncertainty international border closures have caused.

The Morrison Government is making further changes to the Family visa program to support applicants impacted by the COVID-19 pandemic. This includes providing visa holders flexibility to remain in Australia, or to continue their visa pathway even if they have been unable to travel due to the current international border restrictions. The changes are in addition to the Government's decision to almost double the number of Partner visa places in 2020-21.

Protecting Australians from Scam Calls

Scam calls aren't new, however they are getting more sophisticated, and many Australians still fall victim to them.

So far in 2020, Australians have lost nearly \$36m to scam calls. This is a reminder to be vigilant and avoid giving your details to people over the phone.

Honouring the Hon. Warren Snowden MP

It is rare that I pay tribute to someone on the other side of politics in these newsletters but I wanted to acknowledge the service of a good Labor man and a very significant Australian. Last week, the Hon. Warren Snowden MP, the longest standing Member in the Federal Parliament at 31 years—and the last Member left in the Parliament to have served in Old Parliament House—announced that he won't run again at the next election.

Representing the electorate of Lingiari in the Northern Territory, Warren has devoted his life to the betterment of Indigenous Australians, bringing to the Federal Parliament a wealth of knowledge, understanding and experience of Indigenous people.

Warren and I are on opposite sides in Parliament and don't always agree, but I have

had the privilege of working closely with Warren as my Deputy Chair for my work as Chair of the Standing Committee on Indigenous Affairs. He has always been generous in sharing his knowledge and has been a very good parliamentary colleague. He made mention of our work together in his speech announcing his retirement from the Parliament, saying *"I want to briefly pay tribute to the cooperation across the parliament on parliamentary committees. We have the adversarial politics across the chamber; we all understand that. But the truth of it is this parliament works really well in the committees. My colleagues who are here and who chair the committees that I've been on over the last little while will, I'm sure, agree that we've been blessed by the way in which the committee system has worked... And I thank the Member for Berowra for his companionship and good work. He's a good person."*

I wish Warren all the best in this next stage of life and all the health and happiness as he spends more time with Elizabeth and their children.
