

### Public Meeting – Beecroft Shopping Village Redevelopment Why the Amended DA for the Module Site fails to meet Council DCP requirements Monday 31 March, Cheltenham Recreation Club, 7 for 7.30


Your Civic Trust is concerned that the current amended DA for this site still fails to meet all the requirements of the Council DCP. Unless there is significant resident backlash and pressure on Council to recommend rejection, the proposal is likely to be accepted by the JRPP (Joint Regional Planning Panel). Our community needs your action.





## Saturday April 5 – Replant our Heritage – Secure our Future Entertainment from 10.15 and Addresses from 11am Beecroft Memorial Gardens, Wongala Crescent.

Support this community event organised by the Save Beecroft and Cheltenham Alliance. Come and hear local resident and well known horticulturist **Graham Ross, Jack Mundey** and many others speak on how we as a community can help replant our heritage. This includes revegetation of the park and along the rail corridor following the clearing caused by the ETTT and the loss associated with the proposed North West Rail Link



Residents were horrified to see this truck parked right against one of our historic Bunya pines. An arborist said "This is totally unacceptable. Where are ETTTA & Active Tree Service's adherence to AS 4970 THE PROTECTION OF TREES ON DEVELOPMENT SITES? This also means civil construction." We have been told that ETTTA sought and received permission from Council to access the area around the Bunya Pine for the purposes of root mapping. The objective is to locate the important roots around the tree and guide where to place work around it to minimise root damage.

So much for parking a truck on this root zone!

In another example, a tree at the Northern end of Beecroft station behind the blue screen (within the work-site) has been observed to have heavy equipment either parked very close or equipment left leaning against the trunk of this tree. It is one of the last surviving heritage trees in that area. There are no protection barriers are around the tree. Apparently ETTTA 's consent does not require them to have barriers around trees. So much for the Government protecting our environment!

## The Many Whys for NWRL??

Barry O'Farrell promised Sydney that he would build the North West Rail Link (NWRL) as a compatible double-decker service. So why has this undertaking changed? It seems the only three people that think that the downsizing of the NWRL to a metro is a sensible solution are Barry O'Farrell, Gladys Berejiklian and the NWRL Project Manager, Rod Staples.

The people of Sydney need to do whatever is necessary to reverse this decision before it is too late. Spending \$8.38 billion of tax payer's money to build a privately operated shuttle service with no chance of integration into the

Sydney network is incomprehensible. What is required is a parliamentary inquiry into the reasons for the change. There are many unanswered questions.

#### We need to know:


- Why did Barry O'Farrell state that he is saving \$200 million by building smaller diameter tunnels without any
  costing of the alternatives or evidence to back the assertion?
- Why will passengers from Rouse Hill have to stand for 37kms to Chatswood and then wait on a critically over-crowded platform to join an already crowded train into the city?
- Why is the State Government spending \$8.38 billion on a shuttle line that can never integrate with the
   Sydney rail network and gains no efficiencies through using existing maintenance or other support services?
- Why is the State Government gifting use of the state owned Epping to Chatswood line to a private operator without public discussion?
- Why is the State Government refusing to release non-commercially sensitive e-mails and documentation to and from Rod Staples covering the six months leading up to the decision to change from double-decker to metro?

The Transport Minister can avoid a complete disaster by building the tunnels large enough for the operation of a double-decker service to permit future integration into the Sydney rail network.

Over 2000 residents have signed the BCCT petition protesting against the changes to the tunnel size. If you have not done so please add your voice to this petition. ### Beecroft Cheltenham Civic Trust 50th Anniversary Dinner

#### **Celebrating 50 years of Community Activism**

On Thursday 27 February, 225 people enjoyed dinner at the Pennant Hills Golf Club to celebrate the Trust's 50<sup>th</sup> anniversary, making it the oldest Civic trust in Australia. Past President of the History Group, Dr Stuart Braga outlined the history of the trust and why it was founded. He noted that 50 years later the issues were largely the same, trees and preserving our unique suburbs, although the job is now much harder. Beecroft matters. Cheltenham matters.

The guest speaker was Dr Meredith Burgmann who grew up in Beecroft and Cheltenham. Meredith is well known for her community activism. Meredith was elected to the NSW Legislative Council in 1991 and was President in 1999. She retired as President in 2007, making her the longest serving female presiding officer in Australia. Meredith amused the audience with her fascinating reminiscences of growing up in Beecroft and then moving to Cheltenham. She was amazed that there were now some 14 houses on the block where they lived in Hull Road and 3 houses on their block in Mason Avenue. But some things have not changed, there is still a Chemist on the corner in Beecroft

and Sparks Shoes is still next door. Many heritage houses and trees have been preserved, thanks to the Trust. However she was dumbfounded to see what has happened to Cheltenham Station and called it a planning disaster.

Meredith spoke of the many community actions which have saved some of Sydney's heritage, its buildings and bushland, as these were not protected by any legislation. Her message was that communities must fight to preserve what is valued, otherwise we lose. We may not always win, but we must try. By fighting, we really get to appreciate what we are fighting for, we develop a strong sense of community and we make strong friendships.

Past President, Carolyn Watt, thanked Meredith and reinforced the need for community activism now. Our suburbs are being destroyed by inappropriate development and we must all do what we can to oppose it.

These people should represent a wide range of community groups including businesses, clubs, churches and community organisations. They do not have to have experience in banking. However, people with experience in banking, accounting and the law are also needed for expert advice.
